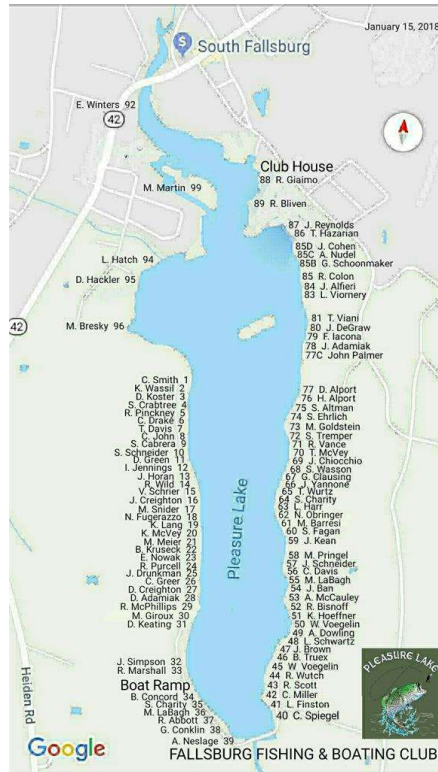
We will discuss the status of our control of Eurasian milfoil and water chestnut as well as harmful algal bloom (HAB) issues, Town efforts to handle issues upstream of our lake and our continued plans to monitor and fight AIS and HABs in the area.

Mick, Bob and Jim C attended the New York State Federation of Lake Association's Annual Conference on May 4th to learn more and network with other lakes, experts and DEC staff to help with our fight to keep Pleasure Lake clean and beautiful.

What are Harmful Algal Blooms (HABs)?

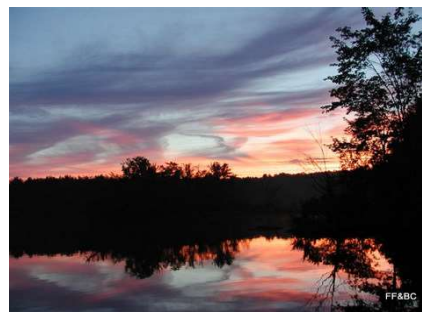
Most algae are harmless and are an important part of the food web. Certain types of algae can grow quickly and form blooms, which can cover all or portions of a lake. Even large blooms are not necessarily harmful. However some species of algae can produce toxins that can be harmful to people and animals. Blooms of algal species that can produce toxins are referred to as harmful algal blooms (HABs).

HABs usually occur in nutrient-rich waters, particularly during hot, calm weather. We are very concerned about the spread

of HABs throughout New York and we are particularly concerned on Pleasure Lake since our lake has always been eutrophic and algae has always been part of our lake experience.

We are watching, testing and staying in touch with the DEC and others about HABs; we are also keeping close tabs on Governor Cuomo's recent initiative to help mitigate or prevent HABs and expect to receive a draft copy of the summit results shortly so we can begin to implement any helpful measures here on Pleasure Lake.

*All watercraft including kayaks and canoes must have lettering at least 3" high identifying the member name. (*ByLaw X, §4; House Rule I*)

* Boats that are new to the lake should be inspected and approved by a member of the Board (including guest boats which must bear the name of the member in 3 inch letters).

ALL BOATS (new to Pleasure Lake or returning) that have been previously used on any other lake or waterway, must be cleaned at our cleaning station at the Clubhouse or must provide proof of steam cleaning of the used boat, or certify that the boat has been checked, cleaned and disinfected or dried and out of the water for at least one month; in addition, every boat/watercraft (**AND ESPECIALLY ANY BOAT TRAILER**) that has been in contact with another lake or waterway and/or stored anywhere outside Club property must be cleaned and inspected at the clubhouse cleaning station and the member

It is our hope that every member will provide an email address and choose electronic delivery in order to help keep your dues lower and avoid waste of paper. About 75% of our membership receives the Call Documents

must certify completion in the log prior to being launched into Pleasure Lake by members and/or third-parties in order to prevent the spread of any aquatic invasive species (AIS) in Pleasure Lake. (*See Amended House Rule AO*)

* Motors (including electric motors) may only be operated on the lake by members and specified family members – not guests or prospective members (House Rule C)

* All floats, rafts, docks and other items must be brought to shore and anchored securely each evening. No floats/rafts are allowed to remain offshore overnight. (HR AN)

* As to any Club lot, members must obtain permission from the Board of Directors before making any changes to the outside dimension of a cottage (including any addition) or any change to any other structure on a lot, or any alteration to the lot itself. (*House Rule AG*)

* Watch your road speeds – 10 mph on all Club roads except 5 mph below the West Shore Hill, and **PLEASE CLOSE ALL GATES.** :-)
